# **Voluntary and Confidential**

- Self-identification is a personal choice.
- You do not need to show proof of your ancestry.
- The information will be securely stored and used only by staff to determine programming and support for students.
- Personal information is collected pursuant to the Ontario Ministry of Education First Nation, Métis and Inuit Policy Framework and will be used to expand supports for students.
- Information will be treated the same as Ontario Student Records and is protected and governed by the Municipal Freedom of Information and Protection of Privacy Act.
- Data may be used by the Ministry of Education and Education Quality and Accountability Office for enrolment, achievement results and course completion. Student privacy will be maintained. Personal information will not be shared publicly.

# Vision

## **ABORIGINAL PEOPLES**

The descendants of the original inhabitants of North America. Section 35(2) of the Constitution Act, 1982, states: "In this Act, 'Aboriginal peoples of Canada' includes the Indian, Inuit and Métis peoples of Canada." These separate groups have unique heritages, languages, cultural practices and spiritual beliefs. Their common link is their indigenous ancestry. At times, 'Aboriginal' and 'First Nation, Métis and Inuit' are used synonymously.

#### INUIT

 People of mixed First Nation and European ancestry. The Métis history and culture draws on diverse ancestral origins, such as Scottish, Irish, French, Ojibwe and Cree.

# HOW TO SELF-IDENTIFY

Students with any degree of aboriginal ancestry are able to self-identify. Students under the age of 18 require parental approval.

No proof of ancestry required.

**CURRENT STUDENT:** Complete a First Nation, Métis and Inuit Self-Identification form and submit it to the school principal. This form is available from the school.

**NEW STUDENT:** Indicate First Nation, Métis and Inuit ancestry on the school registration form.

School administrators are available to support you.

## **THE BENEFITS**

#### For students

- Culturally specific learning opportunities or activities, such as conferences, events or student leadership opportunities specifically for First Nation, Métis and Inuit students.
- Additional support for academic achievement and well-being, including support staff designated to meet Aboriginal student needs.
- Communication between schools, First Nation, Métis and Inuit Education staff, Aboriginal students and their families.
- Connections to post-secondary institutions, community groups, service providers and other partners.

#### For school communities

- More learning opportunities for all members of the school community to develop a greater understanding of Aboriginal perspectives, cultures and histories.
- Schools are better informed about students' needs.
- Schools that need additional Aboriginal programming can be identified.
- York Region District School Board staff are better able to determine if strategies to support students of First Nation, Métis and Inuit ancestry are successful.
