Rationale:

To provide trustees, School Councils, principals and senior administrators with the status of School Council initiatives and a summary of the annual reports received from School Councils.

Background:

School Councils complete an annual report and submit it to the Board. Highlights of each School Council's report are also shared with the school's local community. Annual reports also include a yearend financial statement. The annual reports are summarized and reported to the Board, senior staff, principals and School Councils. The summary is posted on the School Council pages of the Board's website.

Summary of School Council Annual Reports

A total of 178 School Council reports were summarized: 151 Elementary and 27 Secondary. The response rate for Elementary schools was 97% and for Secondary schools it was 90%. Table 1 summarizes the number of responses received from each Community Education Center (CEC) and the respective response rates. Table 2 summarizes the number of responses from the Secondary panel and the total response rate.

QUESTION 1: During your last election process, parent members of council were selected by:

Across both panels, more than two thirds (67% and 83% respectively) of the School Councils responded that the co-chair was not a returning chair.

QUESTION 5: How many new School Council members were there in the past year?

Of the School Councils that responded, the range of new School Council members in the Elementary panel was 0-22 persons, and in the Secondary panel the range was 0-45 persons. Please note the high number of missing responses to this particular question (14 Elementary and 3 Secondary). Of the new schools that responded the range was 6-14 new School Council members in the past year. The mode (the value that occurs most frequently in a data set) response was 3 new members in the past year. Below is a table showing the response categories for schools that responded to this question.

Decision-Making

QUESTION 6a: To what extent has your School Council had opportunities to provide input into the School Plan for Continuous Improvement during the past school year?

Across both panels, a majority of Elementary School Councils and Secondary School Councils provided input into the SPCI during the 2007-2008 year. The table below shows the extent to which School Councils had opportunities to provide input where '1' indicates not at all and '5' indicates to a great extent.

QUESTION 6b: If yes, in what ways has your School Council been involved with providing input into the Plan?

The most common responses to this question dealt with the **review or discussion of the SPCI** by the School Council and **providing comments and feedback** based on those discussions.

There seems to have been some confusion with this question as many School Councils included responses that related to the implementation or use of the School Plan and not to the Council's involvement in the content of the document. To that end, many School Councils reported to have **planned activities and initiatives** using the SPCI. Many also discussed **fundraising and budget planning** around SPCI priorities.

QUESTION 6c: To what extent do your goals and priorities align with the School Plan for Continuous Improvement?

Across both panels, the vast majority of School Councils are aligning their goals and priorities with the School Plan for Continuous Improvement. The table below shows the extent to which School Councils were aligning their goals and priorities with the School Plan for Continuous Improvement where '1' indicates not at all and '5' indicates to a great extent.

QUESTION 6d: In what ways has your School Council <u>supported the implementation</u> of priorities and goals set out in the School Plan for Continuous Improvement?

Curriculum Implementation

As can be seen in the table below, the most prevalent theme in this question's responses is financial support provided by the School Council to fund resources and programs in the school. This general theme occurred in 69% of the Elementary school responses but was not mentioned by any of the fourteen Secondary School Councils who answered this question. In the table below, financial support is disaggregated to show the areas that the School Councils reported targeting with their funds including **literacy** (46% of Elementary School Councils), **math and science** (13%), **technology resources** (19%), and **student health and welfare** (7%). Also common in the Elementary panel but absent from the Secondary panel is **support for the arts** (11% of Elementary).

The most common responses from Secondary School Councils dealt with encouraging **parental engagement** through communication and hosting events (57% of Secondary School Councils). This was also common among Elementary School Councils (22%). Other reoccurring themes in the Secondary panel are the School Council's **involvement in school policies and initiatives** (21%) and **review and discussion of the SPCI** by the School Council (21%).

Elementary School Council responses concentrate on financial support for resources and programs at their respective schools, while Secondary Councils focus on the involvement of parents in the school community.

Parent, Family and Community Engagement

In their responses to this question, a good majority of School Councils in both panels who responded to this question mentioned that they had **hosted or supported events** at their school (76% of Elementary and 60% of Secondary). These events included workshops for parents and community members like Triple P, information evenings and presentations including Literacy and Numeracy Nights, as well as more social events like barbeques and Fun-Fairs.

Other common themes include how the School Council **kept parents and the community informed** through newsletters, flyers and other similar methods (19% of Elementary, 25% of Secondary). Elementary School Councils also frequently discussed how they **funded initiatives and resources in the** school (22%).

School and Workplace Climate

The most common theme cited in both panels was School Council involvement in school safety efforts (25% of Elementary and 36% of Secondary) including school yard safety, anti-bullying initiatives and traffic issues. Also commonly cited in the Secondary panel is **parent and School Council involvement and engagement** in school activities and policies (36%). Many of the themes in the responses relate to student behavior and attitudes including school spirit and student social events (24% of Elementary and 7% of Secondary) which involve events such as special lunches and assemblies as well as extracurricular activities and student recognition programs. Similarly, School Councils were involved in **promoting healthy living to students** (17% of Elementary and 7% of Secondary) through financing of sports equipment, athletics, hot lunch programs and the Healthy Schools initiative, among other things. **Character education** programs were also mentioned by 8% of Elementary School Councils. Themes focusing on the physical elements of school climate included **environmental initiatives and "greening"** of school grounds as well as **other improvements to school grounds**.

Other:

Most of the responses that School Councils wrote in the "other" area likely could have been included in one of the previous three sections of the SPCI. **Fundraising and purchasing resources** was the most commonly reported theme and included things such as literacy resources, extracurricular activities and gates for the parking lot. The most frequent theme cited in the Secondary panel involved **outreach to parents** by the School Council. These responses refer to presentations and events for parents and communication to parents through newsletters, bulletin boards or other means.

QUESTION 7a: Identify documents developed or revised by your School Council this year:

In both panels, the most frequent response was **School Plan for Continuous Improvement / Set of Priorities**. The three most frequently occurring responses were the same in both the Elementary and Secondary School Councils: **School Plan for Continuous Improvement / Set of Priorities**, **Constitution/By-Laws** and **Administrator Profile**.

Other:

The most common theme in the "Other" responses from the Elementary panel is the revision of documents related to the **organization of the School Council**. Also relatively common is the mention of documents meant to **keep parents informed**. As well, four Elementary schools commented that they had **no need** as documents had been revised in the recent past. Secondary School Councils did not include responses that were exclusive of those provided in the question.

QUESTION 8e: In what areas have families been asked to provide input or feedback (e.g., fieldtrip planning, fundraising priorities)?

Among Elementary School Councils, the most common response by a large margin was requesting feedback on **fundraising** (76% of Elementary and 31% of Secondary) which includes both how to raise money and priorities for spending the funds that are raised. Relatively common in both panels were responses related to **school events**. The two most frequently identified support or training Secondary School Councils would like to receive in the next school year were: **Opportunity** (**& Financial Support) to Attend School Council/Board Forums, Conferences, Workshops on Topics of Interest** (67%) and **Guidance on How to Recruit New School Council Members** (58%).

QUESTION 18: In which area(s) does your School Council feel your school has shown improvement during this school year (e.g. program delivery – literacy, numeracy, arts, communication to parents; consultation; recognition; community partnerships; etc)? Give clear examples to support your statement.

One of the most common themes in the wide-ranging responses to this question is communication. Specifically, both Elementary and Secondary School Councils commented on the school and administration improving **communication with parents** (37% and 43% respectively) and **communication with the School Council** (8% and 17%). As well, two Elementary schools mentioned improvements in **communication among staff members** at the school.

Another important trend in the responses is the perceived importance and effectiveness of school initiatives aimed at improving student performance and wellbeing. Literacy initiatives like guided reading, literacy blocks and summer reading programs were highlighted by 41% of Elementary School Councils and 35% of Secondary councils. Numeracy initiatives were cited by 5% of Elementary and 17% of Secondary School Councils. Also, 10% of Elementary School Councils discussed the importance of other school initiatives including Healthy Schools, Eco-Schools and a focus on the use of technology.

QUESTION 19: In which area(s) does your School Council feel your Board has shown improvement during this school year (e.g. program delivery – literacy, numeracy, arts; communication to parents; consultation; support for School Councils; recognition; community partnerships; etc.)? The most common theme from both Elementary (31%) and Secondary (47%) School Councils dealt with communication between the Board and the School Council and parents. Items in this broad category can be grouped into Board improvements in **keeping parents and the School Council informed** through emails and newsletters and comments on **generally good communication** between the Board and the School Council including references to open discussions and town hall meetings on important issues.

The most frequent area (29%) reported as needing improvement for Elementary School Councils was **Communication**. Similar to previous years, they indicated a need to continue to improve Communication, citing a variety of examples (e.g., increased and clearer communications between parents, employees, managers and principals; more interaction and communication between School Councils and Board; improve website; needing communication in a more timely manner).

The second most frequent area (21%) reported as needing improvement for Elementary School Councils was **Parent involvement**. School Councils indicated a need to obtain greater parent engagement in student leaning.

The most frequent area (31%) reported as needing improvement for Elementary School Councils was **Communication**. Similar to previous years, they indicated a need to continue to improve Communication, citing a variety of examples (e.g., too little communication, timely communication, more direction at the beginning of the school year, council specific information could be sent directly to the council chair, request of a board contact, etc.).

The second most frequent area (28%) reported as needing improvement for Elementary School Councils was increase support/funding of programs at school.
