- Most donations were a minimum of \$30 and tax receipts will be issued from the Board.
- Anders and Adil will review the choices parents made on where to direct the funds and provide a chart for next meeting.
- \$285 was raised in Toonies to the Terry Fox Run.
- Kim reported that the Big Box of Cards company is not currently running the program and that they are looking to book for spring dates if we wish to proceed. She will look into the spring dates.
- Discussion arose around seeking other similar type fundraising ideas ideally where something tangible is provided in exchange for a donation.
- Ms. Palmer provided a draft letter that can be taken to local businesses and community partners to request donations and/or gift in kind. Kim will coordinate with Anders, Fiona and Jim on arrangements for picking up donations where requested.
