- School start-up recap growing more and more students are registering, 760+ students, 67 staff, 10+ lunch assistants (need lunch assistants). We had to reorganize junior & intermediate grades per board mandate due to large class sizes or risk fines from the Ministry. New classes will start next week, Sept 26, including some splits. Staff are familiar with this, willing to share & have resources for teachers to support teaching splits. Lots of aspects come into place when making decisions on how to split up classes. Q When communicating to parents/students? Hope to communicate to child on Thursday, can't guarantee. Teachers are getting release time to discuss with Admin. How to tell kid before parent? No won't do that.
- EVS if transfer request is in place, will do so. Know of 1 student joining us on Sept 26.
- Terry Fox Run Day Thursday, Sept 22 Assembly started to discuss this, first time in 2.5 years!
- Diamond Day Faith Days next week.
- Safe Schools Week next week starting on Wed. Sept 28 with a Safe Schools Assembly for on Sept 29. -> Q: Assemblies can parents attend? I.e. Terry Fox, Remembrance Day. Naz to look at fire capacity.
- Volunteers: No limitations on this, just require a Vulnerable Sector Screening. Existing volunteers can sign on an annual basis. YRDSB has a link, which will assist us in turnaround.
- Orange Shirt Day September 30 Canada's National Day for Truth and Reconciliation
- Curriculum Night is Oct 6. To include X-Movement. We'd like to have a BBQ/food/bev options BBQ (sub-committee working on this)
