Assessment of Student Work while Learning at Home

We know families are concerned about students falling behind academically. We will be doing our best to support the continuity of learning for our students during this unprecedented time. We know you may have questions about how students will be assessed for the duration of this school year. Please be aware of the following:

- All secondary students will receive a final report card at the end of this school year.
- Teachers will continue to assign learning tasks that will be marked by their teachers for the purposes of formative and summative evaluation.
- Teachers will communicate results of these marked assignments to students.
- Results will be used by teachers to inform students' final course marks, in cases where it results in the mark remaining the same or improving.
- Final marks can only remain the same or increase based on evidence of learning gathered from April 6 and onward.
- The weightings of all assigned tasks can be adjusted in determining a final grade.
- Final examinations will not be occurring this year and the 70/30 per cent breakdown may be adjusted.

Full Disclosure Timelines for All Students in Grade 11 and 12 Courses

May 1

Teachers will share mid semester mark updates, via TeachAssist, with students in Grade 11 and 12 courses. Parents and Guardians will need their child's password in order to view the mid semester mark updates on TeachAssist.

May 1 - 8

Students may contact their alpha Guidance Counselor (see below) by booking an appointment using TeachAssist to have a pathway discussion and/or to drop a course if needed. An email from a parent/guardian giving permission is required if the student is under the age of 18 and would like to drop a course. Once students book an appointment, they will need to email the counsellor to provide specific contact information (i.e. their phone number). Please note that the counsellor will be calling from a 'blocked' or 'unknown caller' number.

Synchronous Learning Guidelines

As you know, YRDSB continues to explore different opportunities to learn from home, connecting students and teachers through technology with the safety and well-being of students in mind. With the Ministry of Education having extended the duration of the school closure, there is an opportunity for

staff, if they choose, to offer synchronous "real time" live support to students, in order to enhance the asynchronous online learning environment currently provided.

- Asynchronous refers to activities that are not happening simultaneously or in "real time".
- Synchronous refers to activities that are happening simultaneously or in "real time".

As usual, teachers will continue to post learning activities for classes in their online learning platforms each week. Teachers may choose to identify "real time" synchronous activities that involve two-way audio/video conferencing. This will offer an opportunity for students to engage with one another and the teacher in a one-on-one, small/large group, or whole class setting. When these synchronous activities occur, teachers will provide information as to the day, time, and login instructions.

By students participating in "real time" synchronous teaching and learning, students and families are agreeing to the following responsibilities:

- YRDSB Appropriate Use of Technology Policy and Procedures will apply to all learning at home activities.
- Rules of conduct and behaviour for the regular classroom also apply to the virtual classroom.
- Appropriate student dress is required as applicable at school.
- Parents/guardians should be mindful of family activities that would potentially be heard/seen during the students' use of audio/video conferencing.
- Students/parents/guardians shall not take photos, screenshots or record any video/audio from these conference sessions.
- No aspect of a Google Meet session will be posted to any social media sites or through any medium.

Please note that participation in the "real-time" synchronous teaching and learning activities is not mandatory. If a student is not able to participate in synchronous support, an alternative arrangement will be made to ensure each student has access to the learning. Further, students may choose to participate in some synchronous activities and not others or decide only to participate asynchronously. If at any time you have questions about synchronous activities, please connect with the teacher via email.

Jewish Heritage Month

Throughout the month of May, we celebrate the contributions Jewish Canadians make to our great country and our great province. At YRDSB, we are committed to improving the well-being and achievement for all our students through engaging, equitable and inclusive learning environments, as well as curriculum and culturally relevant pedagogical opportunities. As we enter the month of May, staff and students are encouraged to engage in online opportunities, while practicing social distancing, that celebrate Jewish Heritage and the achievements of the Jewish community.
