 - b. Play structure needs repair. School Council is responsible for cost of repairs because it was a School Council purchased item. It should still be under warranty. School Council will review options.
 - c. Active school routes to school safety campaign. Challenges in the parking lot. Please contact Ms. Grey if you would like to volunteer to assist with Parking Drop-off/ pickup zone traffic management. Need a parking lot crew!
 - d. Good news assemblies: Three scheduled assemblies to highlight progress/improvement and successes of students. K Gr. 4 and Gr. 5 8. The dates for the assemblies are Nov 29 (celebrating Responsibility and Collaboration); March 5th and June 4th
 - e. Constitution and bylaws committee. Committee will review existing and recommend updates.
 - f. Presentation: Voyager project run by Metis community member Christian Pillon. He brings a week-long Canoe building project to the school. All classes will get approx.. 2 visits of 20 mins over the course of the week and a core group of 8 intermediate students will spend the whole week working on the Canoe.

Christian provides Indigenous teachings while guiding students in building the canoe with hand tools. The program will cost approx.. \$8000.00 for the week. School Council has approved an allocation of \$4000.00 from the School Council budget to support. The remaining cost will be provided by a grant (approval pending) from the YRDSB. Ms. Gray asking for SC support with moving forward with this project.
